## Filing Rules & Procedures

As the filing party, you are responsible for monitoring the email address (s) you are submitting your electronic filing from. In the event there is a need to return the case for an amendment or additional verification, notices will be issued to the originating email address. Once the case is amended or verified, it must be resubmitted to the American Arbitration Association via the designated platform:: https://nysinsurance.adr.org/simplefile.

Cases must be submitted with adherence to the following:

- · Filing fees are due at the time of case submission
- PDF format only
- One case per email with one attachment only
- AR1 or NF-10 must be signed
- Submissions are not to exceed 64MB in size; if the case is larger than the set size the submissions must be mailed into the center
- As the filing party, by regulation you are responsible to send a copy of your intent to file arbitration proceedings to the respondent (default by mail unless otherwise agreed upon by the respondent)

If at any time a case is submitted in error, or you would like to pull the submission back, please email your request to our Intake Managers listed in the contact section below with a copy of the email receipt. Every effort to locate cases will be made, but there are no guarantees. In the event the case is entered, processed, and assigned a AAA case number, you are responsible to withdraw the case accordingly and the filing fee is nonrefundable.
