# ADD AND REMOVE AUTHORIZED USERS

#### ADD AND REMOVE AUTHORIZED USERS

- ADR Center will provide a company with the ability to add AUTHORIZED USERS to its account in order to grant internal users access to NY No Fault cases for that company
- Only the "ADMIN" person(s) (as designated by that company) has the ability to add users
- A company's "ADMIN" person also has the ability to remove users from their company's account
- A company can also set multiple users to be an "ADMIN" person, if needed



Once logged into ADR Center, access your "My Account" menu by clicking on the link at the top of the landing page (left of LOGOUT). When logged in, the My Account tab will display your name.

In the example above, ADMIN, has been entered as the user's name.

The user has now been added as an authorized user for the company's account. To add more authorized users, simply click the **Add a new user** button again and repeat the process.

You also have the ability to indicate whether or not the new user can act as an ADMIN USER by checking the box next to their name under the ADMIN column. This will give that user administrative privileges to the account and will allow that user to add additional users, if needed. Uncheck the box if you want to revoke their administrative privileges. This can only be done by the current ADMIN user.

To delete a user, simply click REMOVE next to that user's name. You will receive a confirmation that the user has been successfully removed.
